COURSE DESCRIPTION

This supplemental theory course is designed to support graduated students who are in the process of obtaining their professional license in Barbering, Cosmetology, Esthetics, and Manicurist. The course reinforces the theoretical knowledge evaluated on the State Board Examination.

This course does not replace any portion of the regular academic program and does not substitute state-required program hours.

LEARNING OBJECTIVES

- Identify safety and infection control regulations
- Recognize key theoretical concepts by license type
- Apply technical vocabulary in Spanish and English
- Analyze State Board-style exam questions
- Strengthen areas of opportunity based on exam weighting

PROGRAM STRUCTURE

- 22 official theory topics
- Each topic is taught over two consecutive weeks (Spanish / English)
- Course content remains the same; only the language changes
- After Topic 22, the course returns to Topic 1
- Continuous rotating program offered year-round
- Students may join at any point in the rotation
